General Information

<u>AAC Trial Rules:</u> This sanctioned trial is being held under the rules of the AAC. All obstacles conform to AAC Specifications. The trial is open to all dogs over 18 months of age. No bitches in season, dogs suffering from injuries, or dogs showing signs of aggressiveness will be permitted to run. In the spirit of sportsmanship and fairness to others, the disregard of AAC rules will be grounds for dismissal from the rest of the trial weekend and no entry fees will be refunded. As well a complete report will be forwarded to AAC for further disciplinary action. Pye K9 Kapers Agility Club reserves the right to refuse any entry.

AAC ID Number: All dogs must be registered with AAC with a valid AAC number in order to compete in this trial.

Junior Handling: A Junior Handler class will be offered at this trial. Junior handlers must apply to AAC for a number. Forms are available on the AAC website.

<u>Accessibility Option:</u> Senior handlers 65 years and over, and handlers of any age with a disability may request a modified course time and a modified points requirement. The handler's dog shall be entered at its current competition jump height and category, including Junior Handler. The modified time and reduced point requirements are a concession for the handler, not for the dog. Requests must be indicated on entry form.

<u>Bitches in Season:</u> Bitches in Season will be allowed to participate in the trial. Handlers are required to notify the trial secretary that they will be running a BIS at the event as soon as it is known. Handlers should minimize exposure of their BIS to other dogs and limit their movements about the grounds. Competitors will be notified there is a BIS on site. A protective mat, provided by the competitor will be used at the start line. Protective panties are optional. BIS will run as a group at the end of each class. BIS will be marked on the gate sheet next to the dog's name so that other competitors, the gatekeeper and ring crew are aware. BIS must use a designated relief area and must wear protective "panties" when not running or within the designated relief area.

Warm up Area: A warm up area, as required by AAC, will be provided.

<u>Deadline and Changes</u>: No entries will be accepted, changed, withdrawn, after the closing date, with the exception of 1) Dogs may move up to the next class by informing the secretary prior to the trial. 2) Bitches in season or dogs who have been injured after closing date may request a refund upon presentation of a veterinary certificate.

<u>Ring Ready:</u> Exhibitors are responsible to check the running order posted by the ring and be on deck and ready to run. Failure to do so may cause you to lose your turn.

Equipment: Electronic time, a breakaway tire, and rubberized contacts will be used at this trial.



Confirmation: Confirmation will be sent out by email after the closing date.

<u>Move-ups</u>: Move ups are allowed at this trial. A move-up form will be located outside the scoring trailer. Fill out information and all updates will be recorded at the end of each date.

Accommodations: There will be dry camping available on site, with no electrical hookup. Please let us know if you plan to camp on site. Close by, pet-friendly accommodations include: Mactaquac Provincial Park is about 5km from the trial site on Hwy 105. Woolastook Campground is about 8km away on Hwy 102. Hampton Inn & Suites by Hilton, Quality Inn Amsterdam and Comfort Inn which are all in Fredericton about 20km from the trial site

Directions to the Trial Site: Traveling West on Hwy 2 take exit 281 (Hanwell Road). Turn left on Hanwell Road and go past Tim Horton's on your right. At the next set of lights, turn left on Prospect Street. This will turn into Hwy 102. Travel 12km on Hwy 2 and you will see the Keswick Ridge/Mactaquac exit (there is no exit number). Take that exit and keep to your right. You will see Riverside Resort and Conference Centre on your left. Travel across the Mactaquac Dam and take the first right after the Dam. This is Hwy 105. Travel about 4km on Hwy 105 and you will pass an intersection for Crocks Point Road on the right and Route 616 on your left. Just past this intersection is our field on the right. There will be a sign marking the entrance.

<u>Directions to the Trial Site: Traveling East</u> on Hwy 2 take exit 258. Follow signs to Fredericton and Mactaquac. Travel about 12km to the Keswick Ridge and Mactaquac exit (there is no exit number). Follow the directions above starting at "Take that exit and keep to your right."

<u>Biathlon</u>: AAC's biathlon is an Agility AND Jumpers with Weaves class. Dogs who run BOTH Agility and Jumpers with Weaves under SCT (Time PLUS Faults) will earn an International Biathlon qualifier. Biathlon is recommended to be entered as a combined entity over two rounds (Agility and Jumpers with Weaves). However, the K9 Kapers are also offering it as individual rounds (enter only Agility or enter only Jumpers with Weaves) for a chance to earn a qualifier at whichever level you are currently competing.

AAC Class Descriptions:

- <u>Starters:</u> Open to dogs that have not earned a Starters title.
- <u>Advanced</u>: Open to dogs that have earned a Starters title, but not earned an Advanced title.
- <u>Masters</u>: Open to dogs that have earned an Advanced title.
- <u>Regular</u>: Dogs will jump standard heights and course times as set by AAC.
- <u>Specials:</u> Open to all dogs. Course times and jump heights will be as per AAC rules.
- <u>Veterans</u>: For dogs 7 years of age or older, in the case of dogs currently competing in any Regular Agility class. This class shall also be for dogs 5 years of age or older who have been competing in Specials for a minimum of one calendar year. A dog may no longer compete in Regular classes



once entered in an official trial in any of the Veteran classes. Course times and jump heights will be per AAC rules.

- <u>FEO</u>: For Exhibition Only. Competitors are offered the option to enter classes "for exhibition only". FEO entries are not eligible to "Q" nor are they eligible for placements. FEO entries will not be judged. FEO
- To enter, participants must have an AAC number.

Please Note: In order to offer all competitors a smooth-running, relaxing trial, all entrants are expected to volunteer. A volunteer grid will be shared prior to the event.

The link to the volunteer grid will be posted to our Facebook page approximately 1 week before the trial. Sign up for 2-3 jobs each day that you're competing. Kapers members please sign up for 3 jobs each day.

Notice to all Youth and Student Handlers: To promote the sport of agility to all younger handlers, we are offering a reduced fee for all runs. Fees for student handlers, regardless of age, will be \$10.00. For our Junior Handlers we are offering \$8.00 per run.

AAC Registration Agreement

Note: This agreement must be signed prior to participation for valid entry.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the organizing committee shall deem to be sufficient.
